AGENDA ITEM #1

Darren Braddy open the public hearing on site at 420 FM 1528 Cooper, TX 75432, to discuss the annexation DCAD Prop ID #_____. Darren explained the school had bought these properties and had intentions of turning the home into the daycare center and could further expand the school in the future when needed with the new available land.

Mayor Darren Braddy presented ordinance #01-11-25 allowing the school to annex the property at 420 FM 1528 into the city. Darren explained this was great for our school and community.

ORDINANCE #01-11-25

AN ORDINANCE OF THE CITY OF COOPER, TEXAS, ANNEXING TERRITORY TO THE CITY OF COOPER, TEXAS; FINDING THAT ALL STATUTORY REQUIREMENTS HAVE BEEN MET; PROVIDING THAT THE ANNEXED TERRITORY SHALL BE A PART OF THE CITY FOR ALL PURPOSES; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

Scotty Deatherage made the motion to approve Ordinance #01-11-25 allowing the school to annex in property at 420 FM 1528 Cooper Tx, 75432. Linda Barnes seconded. Vote unanimous.

Darren Braddy introduced Jeffery Boyd. Jeffery explained to the council that he has been working on remodeling the home at 731 E. Waco for Hardeep Singh, Hardeep also owns the Cooper Mart gas station. He explained that Hardeep would be living in the house himself once remodel is completed. Jeffery explained that Hardeep would like to re-plat this property in order to build two new rent houses that would face E. Ft. Worth. Jeffery said there would be 2, two beds and one bath homes. He also explained since Hardeep would be there close, he would be able to stay on top of these houses being well maintained. Jeffery presented drawings showing how they wanted to split this property up and showed it would still be in compliance with the minimum of 4000 sq ft lots.
