AGENDA ITEM #1

Darren Braddy opened the public hearing on the re-zone of Delta County Appraisal District (DCAD) Property ID #5331 650 W. Austin and DCAD Property ID #6016 201 N.W. 4th. Darren introduced Duke O'Neal to speak on this matter. Duke stated that he had purchased the two properties with the intent to construct a duplex rental structure on each lot. Dean Eudy stated that he was concerned that this action would attract low-income renters which involve Section 8 housing assistance. Duke O'Neal stated that the structures would not involve Section 8 housing assistance. Dean Eudy also stated his concern regarding the sewer issues in this area and also drainage. Margaret Eudy stated that she was concerned about changing the laws that currently protect the current property owners in this area as they have lived here for fifty plus years and it has always been zoned single family. Linda Barnes stated that she was opposed to the zoning change for DCAD Property ID #5331 650 W. Austin but she was not opposed to the zoning change for DCAD Property ID #6016 201 N.W. 4th because ID #5331 had single family homes in the area and ID #6016 did not, #6016 has an apartment complex in this area. Duke O'Neal stated that actually there are homes in both areas. Melissa Millard asked if the properties would be maintained by Duke O'Neal. Duke stated yes. Hearing no more comments on this item, Darren closed this public hearing at 5:43 PM.

Mayor Darren Braddy presented Resolution #02-09-25 authorizing the creation of a Sub-Regional Planning Commission Pursuant to Chapter 391 of the Texas Local Government Code and introduced Scott Landers to speak in regards to this item. Scott Landers stated that battery storage facilities and other potential hazardous materials disposal facilities are becoming more common in rural areas. If created, this commission would be able to advocate for the community and ensure accountability with laws for any company that could purchase land for the use of potential hazardous material storage and such. Chapter 391 of the Texas Local Government Code authorizes the creation of regional planning commissions by political subdivisions of the State of Texas to address are-wide planning needs and to foster cooperation among local governments.
